If you discover firearms in an estate, check to see if the decedent had any of the following:

- A revocable living trust that includes firearms
- A dedicated gun trust (especially for NFA-regulated items)
- Instructions in their will regarding firearm distribution
- Documentation of lawful ownership or prior appraisals

### **Revocable Living Trusts:**

For standard firearms, a revocable living trust can help streamline the inheritance process. These trusts allow owners to name beneficiaries and set clear instructions for distribution.

### **Gun Trusts for NFA Items:**

If the estate includes items regulated under the National Firearms Act (e.g., suppressors, SBRs, machine guns), a dedicated gun trust can ensure legal compliance and avoid complications.

### **Legal Transfer Procedures Still Apply:**

Even with a trust in place or Instructions in their will, firearms should still be transferred through a licensed FFL dealer to ensure all background checks and legal processes are followed.
